

General Inclusion Policy

211 Alberta uses the online database www.InformAlberta.ca for resources information and for providing referrals to callers. InformAlberta.ca, through their information stewards, is responsible for collecting and maintaining human service information that enables people to make informed choices to improve their quality of life. The information is published on the InformAlberta.ca website as well as various publications created by the information stewards, including Directories and Resource Lists.

Inclusion Criteria

This criteria applies to services available on the public website.

InformAlberta.ca includes, without fee, the following types of human and social service organizations:

- Services provided by physician(s) or other licensed professional(s) in Alberta that are at least partially covered by Alberta Health Care insurance.
- Private health-related services that could be required in an urgent situation.
- Publicly-funded services providing a direct human or health service.
- Federal, provincial, or municipal government services providing a direct human service.
- Members of Parliament, Members of the Legislative Assembly, Mayors, and City Councillors
- Not-for-profit organizations which provide a human service, program or resource and are incorporated under the Societies Act, and/or have Registered Charitable Status.
- Professional social service organizations.
- Advocacy groups.
- Public education institutions.
- Self-help support groups.
- Networks or coalitions of direct service providers.
- Organizations that are involved in licensing, planning, funding or coordinating direct services.
- Organizations (such as service clubs, churches or social clubs), that explicitly state their intention to make the proposed service available to clients without regard to their beliefs, religion or political persuasion, and who avoid use of the proposed service as a means of attempting to convert clients from one faith, opinion, creed or party to another.

Not-for-profit organizations included in InformAlberta.ca will:

- Have been providing a service for a minimum of one year.
- Reasonably expect assured funding to continue operation for at least one year.
- Have a publishable address and/or phone number.

- Preferably, adhere to the principles and practices of the Canadian Code of Volunteer Involvement (for organizations who utilize volunteers).

Discretionary Inclusion

InformAlberta.ca may consider for inclusion:

- For-profit, private, commercial organizations that provide a community service not sufficiently offered by the non-profit sector and provide services either free or with a significant sliding scale.
- For-profit, private, commercial organizations that are licensed by the government or have special contractual agreements to operate long-term care facilities, child care centres, and certain home care services and provide services at no direct cost to the client.
- For-profit services that have a contractual relationship with a funding organization to provide a publicly-funded service and provide services at no direct cost to the client.

For-profit, private, commercial organizations that provide a community service will:

- Have been providing service for a minimum of one year.
- Have a publishable address and/or phone number.
- Not have volunteer opportunities listed.
- Only have those services included that are provided at no cost to the client or on a significant sliding scale.

Primary Focus Areas

InformAlberta.ca will collect and disseminate organization and service information related to basic subsistence and survival-related services, including:

Primary focus is also given to services for people who may experience barriers to services because of:

Secondary Focus Areas

InformAlberta.ca will consider collecting and disseminating general organization information and volunteer opportunities for services that fall outside the primary focus areas. These may include program and services related to:

- Arts/culture
- Environment
- Festivals/special events
- Museums/historical sites
- Special interest organizations (e.g., Alberta Ferret Society, African Violet Society)
- Recreation/Sports
- Peace/international development/social justice

Exclusion Criteria

InformAlberta.ca will not list:

- For-profit psychologist businesses, including private practitioners, sole proprietors, or other business formats who do not offer a sliding scale fee structure, or who provide services which are sufficiently met by the non-profit sector. Referrals for psychologists are made to the Psychologists Association of Alberta.
- Unlicensed care services or nanny services for children, youth or adults.
- For-profit home health care agencies, who do not offer a sliding scale fee structure, or who provide services which are sufficiently met by the non-profit sector.
- Individual practitioners and groups of consulting practitioners (who have incorporated under another name).

InformAlberta.ca reserves the right to refuse to list or to discontinue listings for the following reasons:

- Organizations that misrepresent, by omission or commission, pertinent facts regarding their services, organizational structure, or any other pertinent matter in any way.
- There is adequate reason to believe an organization/service may spread hatred or have a philosophy that could be hurtful to the well-being of groups, individuals, or the community as a whole.
- Organizations which have had serious complaints lodged against them with any regulatory body, with other organizations listed in InformAlberta.ca providing similar services, or with InformAlberta.ca Information Stewards.
- Organizations that offer or provide services which are unlawful.
- Organizations or services that deny service on the basis of ethnic heritage, religion, gender, sexual orientation, citizenship or any other basis not permitted by law or whose services are divisive or discriminatory.
- Organizations who are not providing the services they claim to be, or have committed fraud, or any other criminal activity.
- Organizations that fail to respond to requests to update information.

Applying for Inclusion

Go to InformAlberta.ca and fill out the form. Your local InformAlberta.ca Information Steward will then contact you directly for further information and to provide the Information Collections Forms for inclusion.

Applications will be reviewed, taking into consideration the criteria, the number of agencies being considered for inclusion, and other relevant factors.
